Karen Kessler, an attorney who worked on the case for the plaintiff's firm, said it was not unusual for a plaintiff to pick a defendant and then change his or her mind. There are ways to block that from happening, such as notice of intent to sue, a request to enter evidence, the decision to go to trial, the settlement of the case or the judge's ruling on post-judgment motions, Ms. Kessler said. If a defendant tries to sue in New York, the defendant must post a bond equal to the amount of the judgment, the lawsuit will be stayed and it can be dropped only by court order, she said. The practice of filing cases against people to scare them into not suing is a violation of New York's anti-SLAPP law, which holds that bad-faith lawsuits against people who criticize or oppose government or business interests are barred. A recent example is a suit by three former New York detectives against their former employer, the city police department. The detectives filed their suit in 2008, under an anti-SLAPP statute that does not exist in Massachusetts, after their former employer, then represented by Mr. D'Alessandro, did not settle a defamation suit the detectives had brought in 2002. The settlement, which Mr. D'Alessandro dismissed in 2006, included the admission of guilt by the department, but it spared the detectives the embarrassment of a public trial on the issue, said Mr. Walker, who was also counsel in the defamation case. The detectives' suit, Mr. Walker said, was "a shot across the bow to intimidate the taxpayer from suing the Department of Justice" regarding the case of a police officer who was charged with selling cocaine. Mr. D'Alessandro declined to comment. Mr. Freres, whose firm represented the detectives in the defamation case
